Anhalt University of Applied Sciences

Statutes supplementing examination and degree program regulations of Anhalt University of Applied Sciences (Live remote proctoring/*Videoaufsicht* in online written examinations/*Online-Klausuren*) of January 20, 2021

On the basis of § 67a, sect. 2 of the Saxony-Anhalt Higher Education Act (HSG LSA) of December 14, 2010 (GVBl. LSA p. 600), last amended by Article 1, paragraph 71 of this Act of July 2, 2020 (GVBl. LSA No. 25/2020, p. 334), the following statutes are issued.

Article I

This statute amends all currently valid examination and degree program regulations for obtaining the academic degree of Bachelor or Master to include regulations on live remote proctoring in online written examinations (*Online-Klausuren*). Online written examinations (*Online-Klausuren*) are examinations which, by their nature, are suitable for being conducted in electronic form and do not require examinees to appear in person in specific examination rooms on campus.

Article II

The following regulations will be included

- in the General Degree Program and Examination Regulations for Bachelor's Degree Programs at Anhalt University of Applied Sciences (*Allgemeine Bestimmungen/Bachelor*) of September 21, 2016, in § 15, as clauses 3a to 3c,
- in the degree program and examination regulations for Master's degree programs at Anhalt University of Applied Sciences (Part 1: General Regulations) dated January 31, 2018, in § 14, as clauses 3a to 3c and
- in all other regulations adopted on the basis of the Framework Examination and Degree Program Regulations for obtaining the academic degree of Bachelor or Master (*Rahmenprüfungs- und Studienordnungen*) of July 21, 2010, in the paragraph "Arten der Prüfungsleistungen" (types of examinations) as clauses 2b to 2d.

"(3a/2b) To prevent cheating during an online written examination ('Klausur'), students are obligated to activate the camera and microphone of the communication equipment used for the examination (live remote proctoring). There will be no monitoring of rooms extending beyond the purposes of exam proctoring. Moreover, video surveillance must be set up in such a way that the protection of the personality and privacy of the persons concerned is not restricted any more than is necessary for the legitimate purposes of surveillance.

(3b/2c) Live remote proctoring is conducted by members of staff of the university (invigilators). Automated analysis of image or sound data from live remote proctoring is not permitted. Automated analysis of image or sound data from live remote proctoring is not permitted.

(3c/2d) Recording the examination or otherwise storing image or sound data of the examination is not permitted. Personal data in temporary storage must be deleted immediately."

Article III

- (1) These statutes come into effect on the day they have been approved by the President of Anhalt University of Applied Sciences
- (2) Issued on the basis of a resolution passed by the Senate on March 20, 2021 and approved by the President of Anhalt University of Applied Sciences on March 21, 2021.
